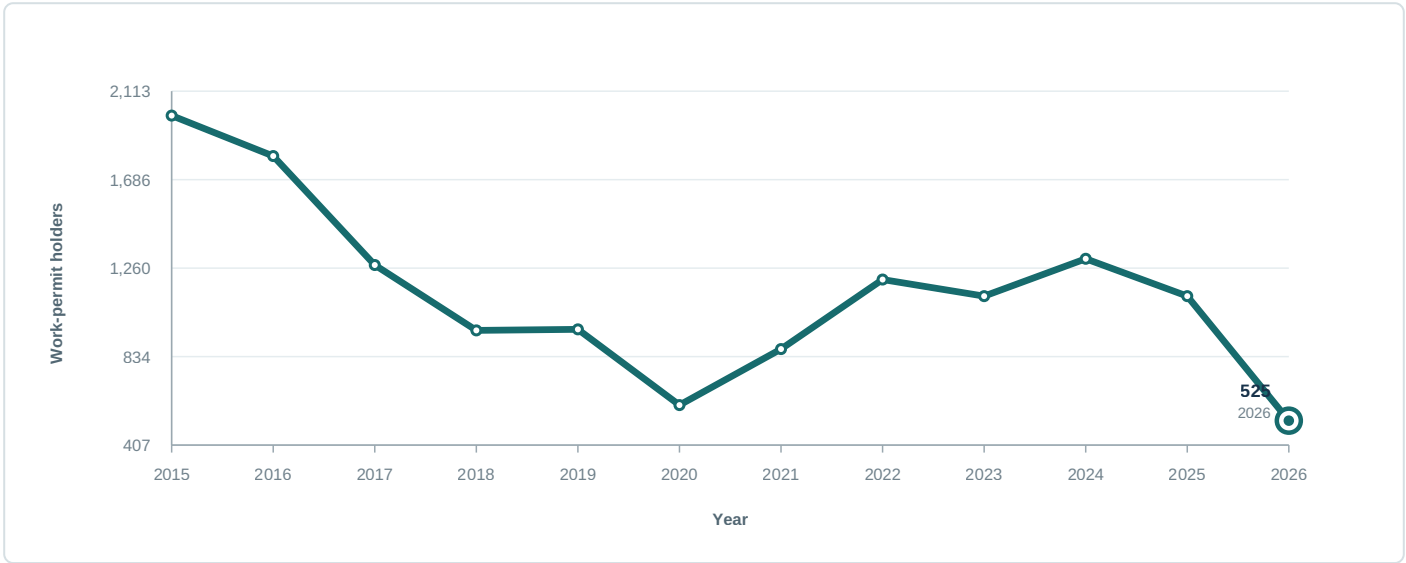

How this report was prepared

This report uses Temporary Foreign Worker Program work-permit-holder data published by Immigration, Refugees and Citizenship Canada. Records are filtered by country of citizenship and the year in which permits became effective.

Annual totals, year-over-year changes, country rankings, summary statistics, and analytical highlights are calculated automatically from normalized monthly source records.

Important note

The figures represent annual permit-holder flows. They do not represent valid permit holders on December 31, people currently present in Canada, positive Labour Market Impact Assessments, or jobs filled.
