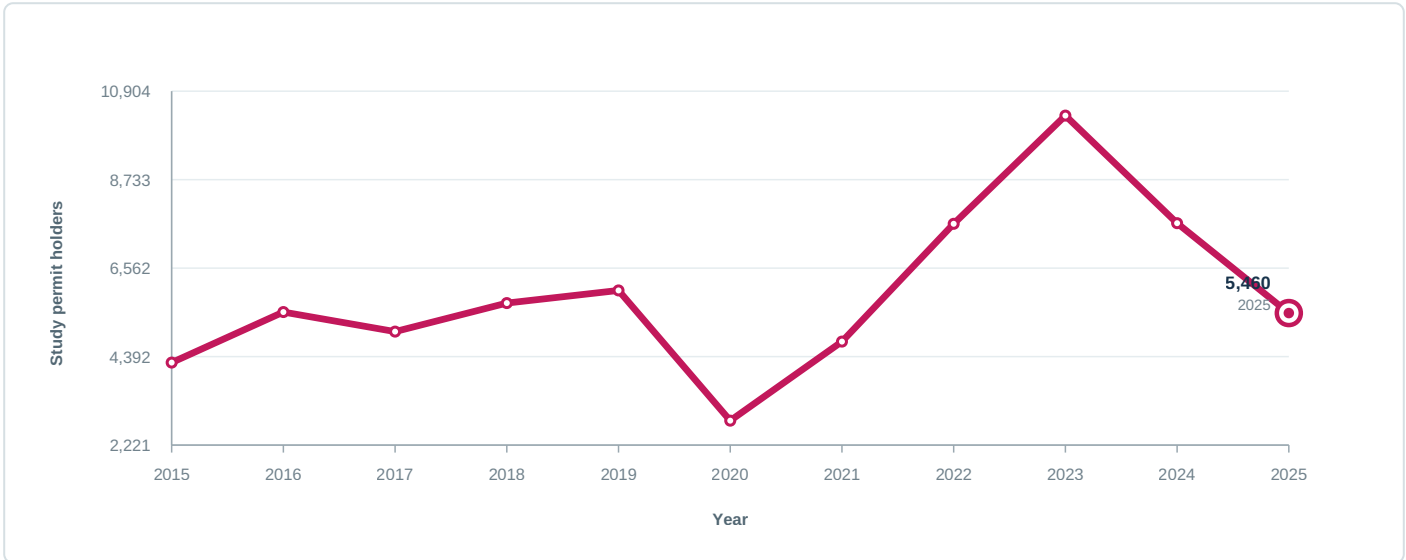

- Below historical peak**

The Sheridan College Institute of Technology and Advanced Learning had 47.0% fewer published study permit holders in 2025 than at its historical peak in 2023.
- Compared with historical average**

The Sheridan College Institute of Technology and Advanced Learning's 2025 published total is 7.8% below its historical average for complete years.
- Rank among comparable institutions**

The Sheridan College Institute of Technology and Advanced Learning ranks #4 among colleges in Ontario for 2025.
- Share of comparable total**

The Sheridan College Institute of Technology and Advanced Learning represents 8.3% of the published study permit-holder total among colleges in Ontario in 2025.
